

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 01-08-2025 13:00 at the office of kalika Municipality Office , Chitwan Redcrossgram, Chitwan Jutpani, Chitwan Bagmati Province Nepal.
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 45000 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[11304010000004] at [Global IME Bank Ltd. , Kholesimal -6, Kalika Municipality, Chitwan] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
